Subject: Withdrawl of employment notification No. Edu/RMSA/Adm/01/2018 dated 19-04-2018.

ORDER

Whereas, under erstwhile Rashtriya Madhyamik Shiksha Abhiyan (Noor Society) an MHRD scheme, employment notification for filling up of various posts on contractual basis against consolidated wages vide advertisement notice No. Edu/RMSA/Adm/01/2016 dated 24-06-2016 was floated for inviting applications from eligible candidates on prescribed format for various category of the posts including Orderlies; and

Whereas, the employment notification so floated did not specify the posts to be filled up separately at the District level and the State level; and


Whereas, the Administrative Department while taking cognisance of this issue instructed vide communication No. Edu/Plan-SE/609/2017-18 dated 25-10-2017 for scrapping of the whole process and issuing a fresh notification with clear distinction of mentioning the District level and State level posts; and

Whereas, acting on the advice of the Administrative Department a fresh employment notification vide advertisement notice No. Edu/RMSA/Adm/01/2018 dated 19-04-2018 under erstwhile RMSA was floated for inviting applications from the eligible candidates for engagement purely on contractual basis for 30 No. posts of orderlies (22 at the district level and 08 at the state level); and

Whereas, the process of filling up of the posts of orderlies so advertised could not be taken further in view of the integration of RMSA (Noor Society), SSA (Ujala Society) and Teacher Education and its conversion into a single scheme namely Samagra Shiksha (Chirag Society) by the MHRD, Government of India; and

Whereas, the integration of three different schemes into a single scheme has caused a blockade to fill up the advertised posts against erstwhile RMSA scheme;

Now, in view of the aforementioned facts the employment notification inviting applications for filling up of 30 posts of orderlies issued under notification No. Edu/RMSA/Adm/01/2018 dated 19-04-2018 is hereby withdrawn abinitio. However, the candidates who have submitted the application forms along with bank drafts of Rs. 200/- can collect the said bank drafts from the Directorate of Samagra Shiksha, Baghat-e-Barzulla Srinagar.

Whereas, under erstwhile Sarva Shiksha Abhiyan (Ujala Society) an MHRD scheme, employment notification for filling up of various posts on contractual basis against consolidated wages vide advertisement notice No. Edu/SSA/1833/17 dated 18-09-2017 was floated for inviting online applications from eligible candidates for various category of the posts viz Programme Officer, Programmer, Research Assistant, Sr. Auditor, Assistant Programmer, Assistant Engineer, Junior Engineer, Auditor, Accounts Clerk, Resource Teacher, Data Entry Operator, Computer Assistant and Orderly/Chowkidar;

Whereas, the employment notification was floated with the condition that the criteria of selection shall be notified separately;


Whereas, vide this office No. Edu/SPD/SSA/1833/1974-78/18 dated 08-02-2018 State Board of School Education, J&K was requested for scrutiny of application forms of candidates as well as conduct of written on the direction of the then Hon'ble Minister for Education during the meeting held on 07-02-2018;

Whereas, this office vide No. Edu/SPD/SSA/1833/446/18 dated 10-01-2018 & Edu/SPD/SSA/1833/3915/18 dated 03-04-2018 requested Administrative Department for providing of criteria for selection of the advertised posts;

Whereas, the process of filling up of the posts so advertised could not be taken further in view of the integration of RMSA (Noor Society), SSA (Ujala Society) and Teacher Education and its conversion into a single scheme namely Samagra Shiksha (Chirag Society) by the MHRD, Government of India; and

Whereas, the integration of three different schemes into a single scheme has caused a blockade to fill up the advertised posts against erstwhile RMSA scheme;

Now, in view of the aforementioned facts the employment notification inviting applications for filling up of posts of Programme Officer, Programmer, Research Assistant, Sr. Auditor, Assistant Programmer, Assistant Engineer, Junior Engineer, Auditor, Accounts Clerk, Resource Teacher, Data Entry Operator, Computer Assistant and Orderly/Chowkidar issued under notification No. Edu/SSA/1833/17 dated 18-09-2017 is hereby withdrawn abinitio.
